1. CONTENTS OF APPLICATION:

I hereby solemnly affirm that the statements made and information furnished in my application form as also in all the enclosures/documents submitted by me, are true. If any information/document furnished by me is found false, I know that I am liable to criminal prosecution and I also agree to forgo my seat in the Institution and also forgo the entire fees already paid

2. FEES:

- a) I undertake not to claim for refund of fees once paid to the College under any circumstances.
- b) I hereby undertake to settle all the dues and outstanding bills to the College and the Hostel in time. I shall vacate the hostel to which I am admitted in case of discontinuing my studies in this College. And I further agree that the College has the right of lien over all my original educational certificates/ testimonials and the College shall have the right to withhold the transfer certificate and any other certificates until the dues/outstanding are fully paid.
- c) i) After the admission, I will pay the balance fees before the commencement of 1st Semester university exam failing which interest @ 14% will be levied thereafter.
ii) Second year onwards the entire fee will be paid in lump sum within 30 days of the reopening of the college, failing which interest @ 14% will be levied thereafter.
- d) I am liable to pay all the fees of 4 years if I leave the college by discontinuing my studies.

3. ATTENDANCE:

I undertake to fulfill the attendance requirement as per the norms of the College and the rules prescribed by the University. As per VTU norms, it is mandatory to have at least 85% attendance to be eligible to write the exam. Any misconduct or indiscipline, Principal has the right to deny permission to appear for the Examination.

4. NO CLAIM AGAINST COLLEGE:

College authorities are not liable for any damages/charges on account of any medical conditions, allergies and injuries, fatal or otherwise, which may be sustained by me, at any time during my stay in College, while taking part in studies, sports and extra-curricular, or any other form of activity of the College, within or outside the College premises, and all expenses that may be incurred in the treatment of such injuries will be borne by me/my parent/guardian.

The management is not responsible for any loss, theft, misplace of any items or things of students viz: laptop, cameras, mobiles, wrist watches or gadgets and other valuable items etc., in the College Campus.

5. CODE OF CONDUCT FOR THE STUDENTS:

- a) Any activity of the student creating willful damage to the credibility of the institute through passing of information via any media viz facebook whatsapp etc., is liable to be dealt under cyber crime. Also instigating any group activity in the college is liable for rustication from the college.

b) I will not indulge in any act which will cause any damage/loss to the property or prestige/reputation of the College; and I will not misuse any facilities (like library etc) of the College. I also undertake to indemnify the College for all the losses that may be sustained on account of any of my acts or omissions. The Management can recover the cost with penalty for the same.

c) I will not conduct myself in any manner which shows disrespect to any staff member of the College or my classmates / Collegemates. I will not participate in any strike or demonstration and will not instigate others to do so.

d) I hereby declare that I understand that the Code of Conduct for the students of this College, which includes the following:

- i) No student shall use/consume/possess any alcoholic or narcotic substance or tobacco or chewing gum etc. in the College premises or when representing the college, and shall not enter the premises of the college under the influence of or consuming any such substance.
- ii) No student shall indulge, either directly or indirectly, in any act of illegal or criminal or immoral behavior either inside or outside the College.
- iii) Every student is bound to follow the rules of discipline and code of conduct set out hereunder and also to follow the further written or oral directions/orders of the Management/ Staff that may be issued from time to time.
- iv) No student shall deliberately abstain from any class, tests or Examinations.
- v) Fees: No student shall be permitted to appear for the Examination unless he/she clears all the arrears due to the College and hostel.
- vi) The College has the right to punish the student for violation of any of the undertaking or code of conduct/directions issued by the College/Staff. The punishment may be in the form of warning, censure, fine, suspension from the College for any period or expulsion from the College. Neither myself nor my parent/guardian shall question any such punishment imposed by the College.

- ii. For students who are applying for scholarship it is mandatory to have an account in **Syndicate Bank** for speedy disposals.
- iii. Scholarship applications will be acceptable only with the submission of current year income certificate
- iv. The candidates with “ZERO” fees and concessional fees whose scholarship is provided by the Govt., should apply in time and seek claim for it , failing which fees has to be paid by the candidates.
- v. On receipt of scholarship, (who are admitted under “ZERO” fees and concessional fees) students are directed to submit the copy of their account details for succeeding renewal of scholarship and issue a cheque or DD within one week which is due for the college.
- vi. A copy of the online scholarship application along with the relevant documents should be compulsorily submitted to the scholarship section. The supporting documents should be signed by the concerned HOD's and the application should be signed by the Principal for further processing.

11. DRESS CODE
